PART I

DELEGATIONS:

1. McGregor, Stewart & McWilliams, Canada Building, submitting invoice in the amount of \$97.76 for expenses incurred by Mr. D.I. McWilliams, Chairman of Council's Windsor Hospital Survey Committee in pursuit of its assignment.

The City Manager recommends as follows:

SUGGESTED RESOLUTION:

"That the account of McGregor, Stewart and McWilliams dated January 18, 1962, in the amount of \$96.76, representing expenses incurred by Council's Hospital Survey Committee in development and compilation of its report, be passed and paid, as a charge to Account No. 216 - Hospital Committee."

Secretary-Manager, Windsor Housing Company Limited, acknowledging advice of Council's recent appointment of Aldermen W.C. Riggs and J.W. Atkinson, and Messrs. K.D. MacLennan, L. Wheelton and A. Munroe, to the Company's directorate, and now requesting that one of the aforementioned be appointed as the City's proxy to vote the City's stock in all matters to be considered at the Shareholders' Annual Meeting.

SUGGESTED RESOLUTION:

"That a member, appointed by Council on January 8, 1962, of the Board of Directors, City of Windsor Housing Company Limited, be delegated as the City's proxy for the purpose of voting the City's stock in the said Company in respect to all matters to be considered at the Annual Meeting of its shareholders." (51E-1)(25A-1)

3. Lithuanian Canadian Federation in Windsor, requesting permission to fly the Lithuanian national flag at City Hall, on Friday, February 16, 1962, in observance of the 44th anniversary of Lithuanian Independence. (19D-1)

COUNCIL FOR DECISION

4. City Clerk, advising that on March 27, 1961, Council considered a request from Riverside Business Association for endorsation of its resolution of March 2, 1961, urging that the Department of Lands and Forests immediately acquire Peche Island for development as a park site to serve the residents of this area. At that time, Council directed that this request be filed, and the Minister of Lands and Forests be urged to establish a provincial park in Essex County on lands abutting Lake St. Clair or Detroit River.

On April 18, 1961, said Minister advised that this matter was already under consideration, and that the need for such park in this densely

populated area was fully appreciated.

On December 4, 1961, the Minister was asked for a report on the status of this matter, and he replied on December 11, 1961, that in a visit to this area, he had seen a 100-acre site "which would seem to fit into the park system operated under the local municipality, and referred to the Parks Assistance Act.

Shortly thereafter, the foregoing letter was acknowledged, pointing out that Council's request in its resolution of March 27, 1961, was for the establishment of a provincial park, which he had indicated in his letter of April 18, 1961, was under consideration. He was asked to indicate whether

this possibility had been abandoned.

By letter dated January 16, 1962, the Minister has replied, stating that "the land area adjacent to Lake St. Clair has been carefully examined and found to be of such nature it would not provide the requirements for a provincial park; however—it would seem to be one which could fit into a parks system operated under the local municipality." He has again referred to the Parks Assistance Act, under which "the municipality may secure assistance for capital expenditures for parks development and this would seem to be the logical method by which an interested municipality could develop a park for their particular purpose. I would suggest you explore this means by which the park needs of your community might be taken care of."

The City Manager comments that the matter of acquisition and development of this site would in his opinion impose considerable additional cost to the ratepayers of this city and in view of the many financial responsibilities including present parks sites undeveloped now pending, it would seem impractical financially for the Corporation to obligate itself. The Province's maximum contribution for any one project is \$50,000. (82A-1)

COUNCIL FOR DECISION.

5. City Clerk, advising that at the westerly extremity of the front (northerly wall) of the former City Hall Building, a bronze plaque had been erected in 1925, inscribed in the French language in memory of Charles Eusebe Casgrain, a local medical practitioner and senator, during his latter years when he resided here.

The plaque remained until demolition of the building immediately prior to which Board of Control (Cl. 16, Report 533, adopted by Council on August 7, 1956) directed that this plaque be retained pending determination of its disposition. It is presently in custody of the Clerk in a basement vault at City Hall.

By letter dated January 27, 1962, the Richelieu Club, a local French-speaking organization has requested that this plaque be released to its custody, as "the proper organization to which to entrust the memorial for safe keeping until a suitable site can be found for it. (73B-1)

COUNCIL FOR DECISION.

6. Industrial Commissioner, requesting an advance of \$12,000 on a 1962 municipal grant, which will be formally requested as soon as his Commission's 1962 budget and 1961 financial statements and report are prepared.

He states that "our subscribers are being asked to provide funds at the same level as in 1961." The advance is necessary to assist the Commission's 1962 programme.

The Commissioner of Finance comments that the City's contribution to the Greater Windsor Industrial Commission in 1961 was \$26,700 and recommends, with the concurrence of the City Manager, as follows.

"That the Commissioner of Finance be authorized to effect payment at once of \$12,000 to the Greater Windsor Industrial Commission, representing an advance on a municipal grant to this organization, and that a formal application for said grant, accompanied by the Commission's 1962 Budget, and 1961 Financial Statements, be considered by Council during its forthcoming Budget Sessions." (46A-1)

7. City Clerk, submitting list of works set forth in Appendix "A" attached, for which sufficient petitions for construction of the works in 1962 as local improvements, have been received, approved by the City Manager and Commissioner of Works.

"That the works set forth in Appendix "A" attached hereto, at a total estimated cost of \$145,000 be approved for construction under the provisions of The Local Improvement Act as part of the 1962 Street Programme, these works having been petitioned for by owners of properties abutting the proposed works, and the City Clerk having certified the sufficiency of said petitions in accordance with the Act; and further, that the City Solicitor be requested to prepare for Council's consideration at its next meeting, a by-law authorizing these works, and that thereafter the City Clerk be authorized to make application to The Ontario Municipal Board for approval of these undertakings, the cost of the works to be financed from \$116,400 to be raised by the issuance of ten-year $5\frac{1}{2}\%$ serial debentures, \$19,400 from the Provincial subsidy under The Highway Improvement Act, and \$9,200 from Federal Government grant under the 1961-62 Winter Works Incentive Programme." (64B-1)

8. On April 3, 1961, Council approved works to be undertaken in 1961 under Section 8 of The Local Improvement Act, two of which works included separately the construction of 30-foot pavements on Somme Avenue, (1) between Walker and Byng Roads, and (2) between Kildare and Windermere Roads.

Consequent to notification and advertisement of Council's intention to construct 30-foot pavements on Somme, six owners of properties flanking Somme between Walker and Byng Roads filed a petition of their objections with the Clerk, and filed individual objections to the proposed pavement with The Ontario Municipal Board. The petition was reported to Council on May 8, 1961. At the same meeting, a delegation of owners abutting Somme Avenue between Kildare and Windermere made representations to Council opposing a 30-foot pavement. Thereupon Council authorized a reduction to 24 feet in the pavement width on both sections of Somme.

The Ontario Municipal Board has approved construction of a 24-foot pavement on Somme between Kildare and Windermere, and in a subsequent report expresses the feeling that the pavement on Somme between Walker and Byng Roads should be 30 feet wide and has asked reconsideration of this feature.

Item 8 cont'd -

After discussion with the Traffic Engineering Department, the Commissioner of Works has advised that 30 feet is the desirable width, but the decision for 24 feet was premised upon the assumption that parking would be prohibited on both sides of the street to provide two lanes for the heavy traffic using this street, particularly from Chrysler plants. A 30-foot pavement providing two 11-foot moving lanes, and an 8-foot parking lane on one side, is preferable. As in their opinion Somme should not be considered an arterial street, it is therefore not recommended that the City assume any more than its normal share of the costs. The City Manager concurs in the foregoing report.

The estimated cost of a 30-foot and a 24-foot pavement on Somme

between Walker and Byng is as follows:

Estimated Total Cost \$21,000.00 \$20,000.00

It will be recalled that when objections were received to the works

Council desired to undertake under Section 8 of The Local Improvement Act,

The Ontario Municipal Board requested advice as to whether Council wished to proceed. Council advised by resolution adopted June 10, 1961, that it wished to proceed, observing the high costs of maintaining the streets involved in unpaved condition, and also because of a policy plan for permanent pavements maintained in good condition throughout the City.

"That as proposed in its Order No. P.F.E. 7162-61 dated November 21, 1961, The Ontario Municipal Board be informed that this Council now concurs in its recommendation for the construction of a pavement 30 feet wide, instead of 24 feet wide on Somme Avenue between Walker and Byng Roads, at an estimated total cost of \$21,000 of which the City's share is \$19,387, and the estimated annual cost per foot frontage against abutting property owners would be \$1.03; and further, the Board be advised that Council is of the opinion that this road does not perform an arterial function to warrant the assumption by the City of more than the normal share of the cost."

9. Deputy Commissioner of Works, submitting report and recommendation, concurred in by the City Manager, respecting the projects in the 1961-2 Winter Works Programme to be financed by debentures. Copy of the report and tabulation of the works is attached hereto as amended by implementing (a) and (b) tabulation of the works is attached hereto as amended by implementing (b).

The Commissioner of Finance, after reviewing the above, recommends with the concurrence of the City Manager that:

(a) Re - Dougall Avenue, Giles Boulevard to Tecumseh Road
Pavement Curb and gutters.

Since it is estimated that there will be a surplus of \$39,000 in the Area "G" sewer costs because of Winter Works Subsidies on this job, it is recommended that application be made to The Ontario Municipal Board to amend the schedule to its Order, P.F.E. 4156-60, issued the 24th day of November, 1960, to include provisions for this work under the Order without increasing the amount of debentures authorized to be issued under the Order since the cost would be offset by Winter Works Subsidies under the Area "G" sewer contract.

(b) Re McDougall Street widening University to Wyandotte Street. It is suggested that since the estimates therefor do not include the cost of acquisition of land required for this widening, that this item be deferred and be resubmitted later for the total cost of this work including the cost of acquiring the land.

Item 9 cont'd -

(c) That the remainder of the schedule submitted under date of January 25, 1962, be recommended to Council for construction under the Winter Works Programme, subject to approval of The Ontario Municipal Board.

(d) That authority be obtained to borrow funds for the temporary financing of this work for the gross amount of \$446,000 to be repaid from the proceeds of the sale of debentures within one year from the date of completion of this work.

(e) That authority be granted to make application to the Department of Municipal Affairs for authority to purchase the debentures to be issued for this work estimated at \$318,600, which debentures are recommended to be issued on a one to ten year serial basis with interest at 5½% per annum.

SUGGESTED RESOLUTIONS:

- (1) "That approval be given to the construction of concrete sidewalks on the streets set forth in Appendix "B" attached hereto at a total estimated cost of \$110,000 to be financed by issue of 10 year $5\frac{1}{2}$ % serial debentures, in the amount of \$83,000, together with a Federal and Provincial grant under the 1961-62 Winter Works Incentive Programme in the amount of \$27,000, and that the Clerk be authorized to make application to The Ontario Municipal Board for approval of this undertaking; and further, that the Commissioner of Finance be authorized to arrange temporary financing for this work." (60B-1)
- (2) "That approval be given to the major reconstruction of Wyandotte Street from Ouellette Avenue to Walker Road, including construction of sidewalks and curbs, pavement repairs, drainage, planing and resurfacing at a total cost of \$170,000 to be financed by the issue of 10 year 5½ serial debentures in the amount of \$110,200, and Provincial Subsidy under The Highway Improvement Act in the amount of \$34,800, and Federal and Provincial Subsidies under 1961-62 Winter Works Incentive Programme in the amount of \$25,000; and that the City Clerk be authorized to make application to The Ontario Municipal Board for approval of this undertaking; and further, that the Commissioner of Finance be authorized to arrange for temporary financing for this work." (60B-1)
- (3) "That the widening to 44 feet of McDougall Street between University Avenue and Wyandotte Street be approved in principle, and that the Commissioner of Works be requested to prepare a plan of survey of this area to indicate the additional lands required for this project, and the Property Director instructed to obtain an appraisal of the necessary lands for Council's consideration." (60B-1)
- "That approval be given to the construction of a 30-foot pavement with curbs and gutters on Dougall Avenue between Giles and Tecumseh Boulevards at an estimated cost of \$44,000 less the Provincial Subsidy under The Highway Improvement Act in the amount of \$12,000 and a grant of \$4,000 Federal Subsidy under the 1961-62 Winter Works Incentive Programme, a net cost of \$28,000 to be financed by debentures to be issued in respect to the expenditure of \$1,604,569 as authorized by The Ontario Municipal Board for financing of the Area "G" Sewer, the construction of the new pavement being necessary by reason of the construction of the sewer with/the street right of way, and further, that the City Clerk be authorized to make application to The Ontario Municipal Board for an amendment to the Board's Order to include this work." (60B-1)

Item 9 cont'd (5) "That the Commissioner of Finance be authorized to make application to the Department of Municipal Affairs for authority for the Debenture Trust Fund to purchase \$318,600 in debentures to be issued for the financing of the City's 1962 Street, Local Improvement, and Sidewalk Construction Programmes." (60B-1)

1. 'Mr. Dorald A. Bondy, solicitor on behalf of George Vuicic, owner of the Rendezvous Tavern, 7324 Riverside Drive East, Riverside, Ontario, submitting application for Council's approval to fill an area having a length 537 ft. 7 in. by a depth of 300 ft. abutting the northerly limit of Water Lots 69 to 73 inclusive, Farm Lot 149, for the purpose of locating thereon a new hotel marina. Approval of this application has been received from the Minister of Public Works (Canada) indicating that the proposed fill and breakwater would not be hazardous to navigation in that area and also from the abutting property owners, the Town of Riverside and Township of Sandwich East. However, the Surveyor General of the Department of Lands and Forests (Ontario) has advised that before his department will consent to this application, the consent of the City of Windsor will be required in view of its pending application for the annexation of the surrounding suburban areas.

Commissioner of Works, with the concurrence of the City Manager,

recommending approval of this request.

SUGGESTED RESOLUTION:

"That the Department of Lands and Forests (Ontario) be advised that this Council has no objection to the request by Clarke, Wheelton and Bondy, solicitors on behalf of George Vuicic, owner of the Rendezvous Tavern, 7324 Riverside Drive, Riverside, Ontario, to construct a breakwater in the Detroit River to fill an area measuring 537 ft. 7 in. in length by 300 ft. in depth abutting Water Lots 69 to 73 inclusive, Farm Lot 149, as shown on the plan prepared by C.G.R. Armstrong, Ontario Land Surveyor, dated August 10, 1961, and identified as No. 3G694, for the purpose of constructing thereon a new hotel marina. (110L-1)"

Planning Director, reporting that the Street Naming Committee recommends that the Windsor Utilities Commission be requested to enact a by-law changing the names of Remington Drive, Yawkey Blvd. and Myrtle Cres. as shown on Registered Plan 1609 lodged in the County Registry Office to Parkway Drive, Sun Valley Drive and Greenview Crescent respectively. The new street names were first recommended by the subdivider of this area, but the change in street names could not be effected by registration of the new plan of subdivision due to a technicality in the registration procedure at the Registry Office. The Windsor Utilities Commission has advised that the new street names are already in effect in this area. SUGGESTED RESOLUTION:

"That the Windsor Utilities Commission be requested to enact the necessary by-law to change the names of Remington Drive, Yawkey Blvd. and Myrtle Crescent, as shown on Registered Plan 1609 lodged in the Registry Office of the County of Essex, to Parkway Drive, Sun Valley Drive and Greenview Crescent respectively, in order that the street names on the Registered Plan at the Registry Office may be changed to coincide with the names selected by the subdivider of this area. (102D-1)"

Secretary, Windsor Association for Retarded Children, advising that the directional sign erected by the Association at the south-east corner of Church and Giles has now been removed and requesting that the agreement with the City dated November 9, 1960, be terminated.

Building Commissioner, confirming that the sign has been removed. SUGGESTED RESOLUTION:

"That the agreement dated November 9, 1960, between the City of Windsor and the Windsor Association for Retarded Children respecting the erection and maintenance of a directional sign on public property at the south-east corner of Giles Blvd. and Church Street, for which an annual encroachment fee of \$1.00 per year has been charged, be terminated, this sign having been removed by the Association. (36D-1)

Mrs. Dora Karlechuk, 3574 Bloomfield Avenue, submitting application for reimbursement from the City in the amount of \$20.00 for expenses incurred on November 30, 1961, to relieve a blockage in a sewer connection serving her house, the blockage being caused by tree roots from a tree growing on public property. Mrs. Karlechuk advises that because of illness of her husband and the fact that she has lost her eyesight, it was not possible for her to come to the City Hall to make the necessary deposit in accordance with the established procedure. She further reports that she cannot read English and therefore did not know the proper procedure to follow respecting this matter.

City Clerk, advising that Council on January 15, 1962, adopted

the following resolution: That the request of Mrs. Dora Karlechik, 3574 Bloomfield Avenue, "48/62 for reimbursement of \$20.00 of costs incurred on November 30, 1961, when she engaged other than the City's contractor to relive a blockage to the sewer connection serving her residence, which blockage was found to be caused by roots of trees on City lands, be referred to the City Manager for further (91K-1)" investigation.

Commissioner of Works, with the concurrence of the City Manager, reporting that his investigation of this matter indicates authenticity of the facts set forth in Mrs. Karlechuk's letter. However, he reports that during the past year, 26 requests were received and refused from property owners for reimbursement from the City for expenses incurred by them to relieve blocked sewer connections since they did not follow the established (91K-1)procedure.

COUNCIL FOR DECISION

Purchasing Agent, submitting a tabulation of tenders received (copy attached) for supply: and installation of corrugated metal pipe sewer outlets at the northerly limit of Hill Street and at the riverfront opposite Askin Avenue, together with the Tender Committees' recommendation, concurred in by the City Manager. SUGGESTED RESOLUTION:

"That the tender of W.S. Fullerton Construction Limited, 843 Central Avenue, the lowest received, be accepted at a price of \$4,998 to supply and install corrugated metal pipe sewer outlets at the northerly limit of Hill Street and at the riverfront opposite Askin Avenue, this expenditure to be charged to Account No. 255-65A. (91K-1)"

6. R.S. Riddell, solicitor on behalf of the British Methodist Episcopal Church, formerly located mid-block on the west side of McDougall Street between University and Assumption, which has been displaced as a result of the City's redevelopment program, advising that inasmuch as the original church was established in its present location in 1852, every possible effort should be made by the City and by the senior governments to provide a new location somewhere within the limits of the redevelopment area No. 1 for the construction of a new church. He suggests that there is land available for the construction of a new church within the area which has not allotted for any particular use, he urges Council to allocate this land for church purposes. He points out that the landin question is known as the Lawson property and is situate at the south-west corner of Assumption and McDougall Street, this/having a frontage on Assumption Street of 92 ft. and 120 ft. on McDougall Street. He points out that it must be appreciated by the members of Council that there is a great sentimental attachment on the part of the Congregation to its present location and furthermore, it cont'd....

must be appreciated that to force the church to leave and build some distance away could and probably would result in complete disorganization of the congregation. He further points out that it should not be overlooked that when construction of the apartments in the redevelopment area is completed, a fair percentage of the apartments will, no doubt, be occupied by members of the church congregation and it would appear to be highly desirable to minimize as far as possible any disruption in the availability of church accommodation for religious services.

Secretary, Board of Commissioners of Police, advising that at a meeting of his Board on January 17, 1962, he was directed to advise that the Board did not favour the sale of the property at the south-west corner of Assumption and McDougall Streets to the British Methodist Episcopal Church as a site for its new building, as this would have the effect of eliminating any possible extension of the police garage, which presently

abuts the westerly boundary of this property.

Property Director, advising that in February, 1961, Mr. Robbins of the British Methodist Episcopal Church congregation requested his office to supply him with a list of City-owned lands in a Residential R3 which might suitable to locate thereon a church. Mr. Tarleton advises that Mr. Robbins was referred to the City-owned property on the east side of Mercer Street between Cataraqui and Elliott but he advised that this site was not suitable as it is too close to another church on the east side of Mercer Street near Wyandotte Street. Mr. Robbins was also referred to a City-owned parcel on the east side of Windsor Avenue opposte Patterson Collegiate comprising Lots 39 and 40, R.P. 97, having a frontage of 60 ft. by a depth of 150 ft. 5 in. On February 23, 1961, Mr. Robbins telephoned his office and requested him to reserve this site for the membership of the B.M.E. Church as it was their intention to negotiate with the owner of the abutting residential property to see if the same could be acquired by the congregation to enlarge the City-owned parcel. On June 21, 1961, the Reverend Edwards called at his office regarding this site at which time he was advised that if there were any inquiries regarding the purchase of this property from any outside source, these offers would have to be given consideration since no commitment had been made by the church to purchase these lands. Mr. Tarleton advises that no further action has been taken with respect to the purchase of this property.

Traffic Engineering Director, advising in respect to the offer to purchase the south-west corner of Assumption Street and McDougall Street and pointing out that as he recalls, it was decided to retain these lands for off-street parking purposes for municipal employees. The property in question will house approximately 45 cars and will partially solve the problem of displacement of present parking facilities.

City Manager, advising of his concurrence in the reports submitted

by the Property Director and Traffic Engineering Director.

SUGGESTED RESOLUTION:

"That in view of the proposed future use of this site as an analysis of the state of t off-street parking lot and as an area for the possible extension of the police garage, the request by R.S. commissioner of Works, with the concurrence of the City Manager, advising that the overall plan for the development of the sanitary landfill site includes a hill having a total height of 60 ft., the northerly slope of which would be used for skiing (and tobogganing) and the remainder as a topographical feature of the golf course. Completion of the hill to the proposed contours will require approximately 1½ million cubic yards of material and his department is currently placing material at the rate of 140,000 cubic yards per annum, which would mean a completion time of some nine years. It is/department's intention however, since earliest conversations with the Ski Club Executive that within a year or two, to have a portion of the hill completed which they could employ during the winter months for their activities while the landfill operations during the winter months would take place on other portions of the site. This, of course, would delay the ultimate completion date. He estimates that a 30 ft. hill requiring approximately 250,000 cu. yds. could be completed and in use in December, 1962, if it is desirable to have some early use notwithstanding the delay in final completion. He suggests that this feature should be clearly pointed out to the Ski Club before finalization of such an arrangement. He further points out that alterations in the schedule would occur in the event of annexation.

City Clerk, advising that Council on January 15, 1962, adopted

the following resolution:

"49/62 That the report of the Commissioner of Works on the proposed development of a ski hill in the sanitary landfille site be referred to the

Windsor Ski Club for its comments. (98A-1)"

It is reported that the other ski clubs in the City would agree that in preference to any time advantage adult skiers might otherwise obtain, the youngsters should be introduced to the healthful and invigorating sport of skiing as soon as possible.

For Council's information, it should be noted that there has been no resolution adopted respecting the construction of a ski hill and no policy

established regarding its completion and use. (98A-1)

Attached is a revised tabulation of the proposed 1962 Winter Works Projects that are to be financed by debenture issue.

It should be noted that Somme Avenue has been included as one of the Works, as it is anticipated that this will be carried out in 1962. It will be further noted that the allowable amount to be debentured is \$343,000.00 leaving a remaining balance of \$24,400.00.

Two other projects, namely, the widening of McDougall Avenue from University Avenue to Wyandotte Street, and the reconstruction of the pavement on Dougall Avenue from Giles Boulevard to Tecumseh Road have been approved by the Department of Municipal Affairs as subsidizable projects.

I would recommend that the Ontario Municipal Board be requested to approve the Dougall Avenue project at an estimated net cost to the City of \$28,000.00 as an added cost to the Area "G" relief sewer. The Commissioner of Finance has indicated there is sufficient funds remaining in this project to cover the Dougall Avenue work.

I would further recommend that the McDougall Avenue project be deferred until such time as an appraisal of the property to be acquired has been obtained by the Property Director. It will only be a matter of a few weeks until tenders have been received for most of the other projects and a more adequate evaluation of the available funds could also be made at that time.

This is to advise that on Tuesday, January 30th last, the above Board opened its Hearing on the above application at 2:00 P.M. in the Family Court Room of the Municipal Courts Building, City Hall Square. The Board was represented by Mr. H. H. Griffin, the Assistant Chief Commissioner, and Commissioners J. M. Woodard and A. S. Kirk.

The Tunnel Corporation was represented by Mr. A. R. Jessup, Q.C., a local solicitor, and the Cities of Windsor and Detroit were represented by the writer and Mr. Robert Reese, Corporation Counsel, respectively.

The Tunnel Corporation's case consisted of evidence given by the only witness who was called, namely, Mr. John M. Gatfield, the Assistant Secretary and the Assistant Treasurer of the said Corporation. The Cities of Windsor and Detroit did not call any witnesses, and their opposition to this application consisted of cross-examination of Mr. Gatfield and the presentation of arguments which were intended to show that on the basis of the evidence submitted by the Tunnel Corporation, no proper justification had been established for the proposed increases in fares.

The Hearing was concluded at 11:30 A.M. on Wednesday, January 31st, 1962, whereupon the Assistant Chief Commissioner stated that the Board would reserve its decision.

The proposed new tariff will of course remain suspended until further order of the Board, and I shall be pleased to keep you advised of further developments in this matter.

At a meeting of the trustees and stewards, held on Friday, May 4, 1962, to deal with property, we were authorized, by an unanimous vote, to purchase property at the corner of Louis & University Aves. for our Church or parsonage.

On the strength of this we authorized our lawyer to start negotiations for this property and instructed him not to complete the transaction until after our arbitration. This was done so as not to prejudice our case with the city.

The transaction was held up after arbitration because first, the lawyer for the Board of Education, and then our lawyer went on vacation. Mr. Riddell, our lawyer, returned to his office on August 20th, 1962. Shortly thereafter he informed us that the transaction was nearly completed.

It is now up to the Members to say wheter or not we will accept or reject this property. It is impossible for us to hold it any longer.

It is our opinion that a piece of property on a corner of this size - 117' x 153'6" - other than this one will cost us \$15,000.00 or more. This property will, because of the interest of the Board of Education in our behalf, cost us \$2,925.00. We feel that, since \$15,000,00 is more than we can afford to pay, you should accept the offer of the property on University and Louis. It would then be held in abeyance until our property committee finishes it's investigation.

In the event that the property committee is able to find a comparable piece of property on a corner of comparable size - ie 117 ft. x 153 ft. 6 in. - at a price within our means, and within a reasonable time- say within thirty days - , four of our Members, namely, Brós. John Richardson, Everett Ball, Thos. Millben and Archie Ball, have pledged themselves to purchase this property from the Church at the price that was paid for it.

A ballot is enclosed for each member of your family, twenty-one or over, that are members of the Church. Please sign your name over the YES, if you are in favour of obtaining this property, or, over the NO, if you are not. A Stamped, addressed envelope is enclosed for your convenience.

All ballots should be in the hands of Mr. McCauley, at 574 Elliott St, East, not later than September 7, 1962.

If anything is not clear to you, you are perfectly at liberty to call any trustee or steward for clarification.


